# **ENROLMENT OBLIGATION:**

Parent/Guardian is responsible for making tuition payment on time and in full by each due date. If your payment is received late, a \$5.00 late fee will be charged to your account. If you need to drop your child from the program, we must receive, in writing a notice either dropped off at the front desk or emailed BEFORE the next session. If we do not receive notice, you will be billed for subsequent sessions until we receive a drop notice.

#### **AGREEMENT TO PARTICIPATE:**

I understand that Flips & Tumbles tumbling gymnastics, trampolining and parkour like, any other situation involving height and movement, involves risk and the chance of serious injury. This participant has no problem that might compromise their safe involvement. I agree that my child will participate in the session in accordance with the specific safety rules and instructions that we have received from Flips & Tumbles NZ before, after and during the session(s).

### **RELEASE:**

I understand that Flips & Tumbles NZ does not carry medical insurance for participants. I hereby consent to have my child(ren) participate in programs offered by Flips & Tumbles NZ. Precautions will be taken to prevent accidents. Simple first aid will be administered to all minor injuries. Parent or emergency contact will be notified if necessary. I hereby agree that myself and my child(ren), waive and release all rights and claims that I may have at any time against Flips & Tumbles NZ, facilities and use or its representatives, whether paid or volunteer, for any accidents, injury, damage, or death that may occur in connection with the gymnastics program or activities related to Flips & Tumbles NZ. I fully understand the risks involved in respect to such programs, and all such documents will continue to be in effect during any further use of Flips & Tumbles NZ facilities or event participation.

## PERMISSION FOR MEDICAL TREATMENT:

## **FEES, CHARGES & CREDIT CRITERIA:**

Flips & Tumbles fees are calculated on a 9-week term basis in correspondence with the dates of government primary school terms.

The full fee amount is due before a child will be confirmed in a class, unless otherwise stated by Flips & Tumbles.

If a child turns up to his/her first class before the total fees have been received by Flips & Tumbles, their participation in this class will be denied. There may be extra charges such as late fees, administration fees that may be additionally charged on top of the existing cost to you. Unless a written application has been submitted for special circumstances.

Athletes that miss training sessions due to sickness or injury, or if a class falls on public holiday, are not entitled to a fee reduction.

An administration fee of \$20 will be charged to meet requests for a change of class, day/time during the term.

We don't do make up classes – the quality and safety of classes would be compromised if we allowed members to do make up classes.

New participants starting partway through a term are charged on a pro-rated basis.

#### **Cancellations & Refunds**

If a child is enrolled in a class and a written cancellation is received more than 7 days prior to the first class, then the term fees will be refunded less a \$50 cancellation fee.

If less than 7 days notice of cancellation is given, the term fees will not be refunded.

If a child is enrolled in a class but does not attend the classes, the term fees will not be refunded.

No refunds or discounts are offered if students need to finish early or arrive late, or take days off.

# Sickness & Injury

In the case of sickness, no make-up sessions are offered. Quality and safety will be compromised if members join classes they don't generally belong to.

Participants that miss classes due to sickness are not entitled to a fee reduction. However, upon application to the Flips & Tumbles Administration Team via email, if a participant is sick or injured for longer than FOUR weeks, with a written doctor's confirmation/medical certificate provided -must accompany all requests- and if the Flips & Tumbles Office is notified before the FOUR weeks missed, then parents may be offered at the discretion of the Administration Team the option of a 50% credit for that time missed towards the following term or any Flips & Tumbles sessions or workshops you wish to participate in. Please note that any special circumstances will be considered with written application.

# **Change of Class**

Any voluntary change of class during the term will incur a \$20 administrative fee. There is ONE exemption:

Cancellation of class due to insufficient numbers of participants. In this case
we may offer a place in another class, or refund for un-attended lessons if
the alternative class offered is not suitable.

Flips & Tumbles reserves the right to change/cancel/combine classes at any time due to low enrolment or any other extenuating circumstances.

# **Holiday Programme Payments**

All Holiday Programme bookings are taken online through our website, if you choose to pay via other methods, administration fees will be charged.

Voluntary change of session time will incur a \$15 administrative fee.

Enrolments on the day (i.e. no advance booking) will incur a \$15 late enrolment fee.

There is no refund for cancellations within 7 days prior to the start of the holiday programme unless a medical certificate is supplied. In this case, a \$15 administration fee applies.

There are no refunds or adjustments on enrolment after the start of each session for any reason.

#### **SAFETY:**

No parents are allowed in the gym area or on the gear, unless authorised by the Flips & Tumbles NZ Manager. Absolutely no children are allowed in the gym area or on the tumbling gear until their class starts. If your child is caught playing on the equipment or is in the gym area without the supervision of a Flips & Tumbles NZ employee, your child will be asked to leave the gym. I, as a parent or guardian, understand that any injuries due to my negligence are my responsibility and Flips & Tumbles NZ cannot be held accountable.
